Overview

This *Graphic Standards Manual* demonstrates the proper use of the Armed Forces Financial Network® corporate logo, acronym (AFFN®), and name to include registered trademarks of AFFN® in connection with participating in, processing with, or receiving any AFFN® services.

These graphic standards are minimum standards and are designed to allow for appropriate flexibility in the use of the AFFN® Licensed Marks. In order to protect the Licensed Marks and to provide the greatest benefit to Participants' proprietary brands, all entities permitted to use the Licensed Marks must adhere to these graphic standards. Participants, Processors and other entities licensed to use the Marks who contract with vendors or suppliers who use the Marks are responsible for such vendor or supplier compliance with these graphic standards.

Specifications

ATM Specifications:

- Each ATM in the Network must display the AFFN® logo, name, or acronym immediately upon being certified "live" in the network.
- The minimum size will be 3½" in diameter.
- The minimum requirements for the letters "AFFN" are 3½", and for the name "Armed Forces Financial Network" are 6".





Armed Forces Financial Network®

Card Specifications:

- Cards must also display the logo, name, or AFFN® acronym (or alternatively the institution may provide for an advertising program).
- However, Cards are not required to be so displayed until such Cards are reordered, or within 18-24 months, whichever is sooner.
- The "BUG" may be placed anywhere on the Cards, and shall be at least %" in diameter.
- The "AFFN®" acronym or name "Armed Forces Financial Network®" may be used on the Card if the logo is not used, and the minimum requirement is ¾" by ¾".



Dos & Don'ts

Use logo as is



Use logo over photos that do not compete with it



Scale logo proportionally

Don'ts...



Do not flip logo



Do not use logo over dark image



Do not use a rule around the logo



Do not alter logo



Do not disproportionately resize logo

Sample Applications

Debit Card

This card is issued by the Armed Forces Financial Network and not for resale. The use of this card constitutes acceptance of all terms and conditions. This card can only be used for PIN point-of-sale purchases wherever the AFFN card is accepted.

This card is not redeemable for cash, cannot be replaced if lost/stolen/damaged, and will expire after the date printed on the front of the card, except where it may be prohibited by law.
